Public Consultation Document on the Basic Capital Requirements (BCR) for Global Systemically Important Insurers (G-SIIs)

Thank you very much for your interest in the IAIS' proposed Basic Capital Requirements (BCR) for global systemically important insurers (G-SIIs).

This is the first of two planned public consultations and it will inform the design of field testing of the BCR, which is scheduled to commence in March 2014. The second consultation is scheduled to commence in July 2014, after field testing, and will provide an opportunity for comments on more specific BCR proposals.

The second consultation will specifically invite comments on a range of questions regarding the BCR and its relationship with other existing and proposed regulatory measures affecting G-SIIs and Internationally Active Insurance Groups (IAIGs), such as:

- 1. Is the purpose of the BCR clear enough?
- 2. At what level should the BCR be calibrated compared to existing national benchmarks?
- 3. Is the BCR expected to be a temporary measure, until the risk-based group-wide global insurance capital standard (ICS) is in place, or will it continue to apply?
- 4. Should a backstop capital measure be introduced to complement the proposed ICS, in addition to or instead of the BCR? If so what should the purpose of such a backstop capital measure be, compared to the BCR?
- 5. Will the proposed approach to valuation of assets and liabilities provide sufficient global comparability?
- 6. Can a reasonable balance of risk sensitivity and simplicity be achieved using a factor based approach?
- 7. How should the BCR be integrated into national or regional frameworks which are in the process of being implemented or modified?
- 8. How should supervisors enforce the BCR in a consistent manner across jurisdictions?

Accordingly, respondents are encouraged to wait for the second consultation before providing input on these questions. In order to facilitate an efficient compilation process, comments must be submitted through the IAIS website www.iaisweb.org and not by any other means (e.g. Word or Excel documents sent directly to the IAIS). We appreciate your understanding and cooperation.
